All applications to the dual MD/PhD program will be reviewed concurrently by the MD/PhD Committee and by the regular Admissions Committee or a subset of that Committee. The MD/PhD Committee will select applicants for the MD/PhD program from those accepted by the College of Medicine Admissions Committee for admission to the MD program. Decisions regarding admission to the dual MD/PhD program will be final and not subject to administrative or other review.

New wording reflecting 9 faculty on the committee:

The Faculty of the College of Medicine-Tucson will elect ~~eight (8)~~ **nine (9)** faculty and will select one (1) MD/PhD student to serve on the MD/PhD Committee. All applications to the dual MD/PhD program will be reviewed concurrently by the MD/PhD Committee and by the regular Admissions Committee or a subset of that Committee.
